



Developing a Prosperous and Thriving Community

Glooscap First Nation was created in the early 1980's when Rita Smith, the first Chief, requested that the area around her home in Bishopville, Nova Scotia be considered reserve land. She worked with a few local Mi'kmaq families to petition the federal government to establish the community. The land encompasses approximately 171 hectares of predominately forested-land.

In 2014 the Council established the Glooscap First Nation Economic Development Corporation, or Glooscap Ventures, to manage the community business and seek out new business opportunities. Currently, Glooscap Ventures is working on a commercial highway development off Exit 8A on highway 101. All profits from the economic development corporation go back to the community.

The community is located less than 60 minutes from Halifax and is served by the Halifax Stanfield International Airport and the Port of Halifax.



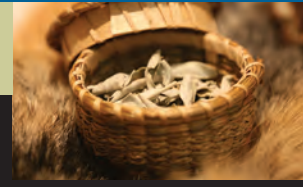

Demographics and Assets, 2015

Total Population of Glooscap First Nation is 366 with only approximately 65 living on the reserve. The members are scattered across Canada and the United States. Currently there are approximately 300 members over the age of 18. There are 30 residential homes, the administrative office, a community centre, a seniors/youth centre, a health centre, store, gas bar and gaming room on the reserve.

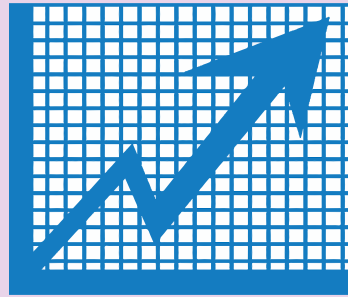

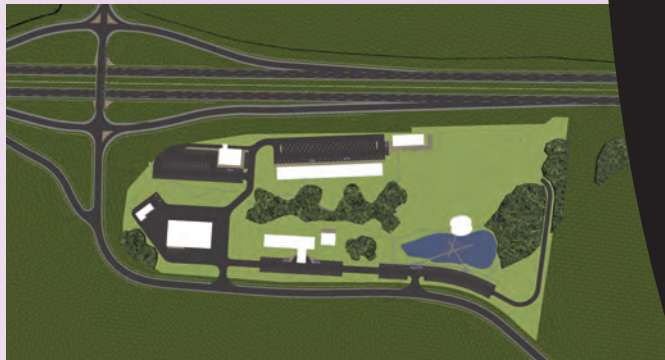

- Glooscap First Nation youth are educated: a high percentage of youth currently pursuing post-secondary education at universities and colleges across Canada
- Glooscap First Nation contributes to the local economy through awarding contracts such as construction and maintenance of buildings on reserve

Education

Approximately 22 of the Glooscap First Nation youth are currently attending post-secondary education at universities and colleges across Canada in multiple disciplines. The community post-secondary rate is high and has been maintained over the past years.
